- Recap of ACEC/NC, Transportation Advisory Board (TAB), transportation committee, and subcommittees
- Current industry concerns, challenges, and best practices, cont.
 - Aviation
 - Industry need for additional resources in aviation small pool of consultants creates potential challenges
 - Increase in innovative technology looking ahead (electric/hybrid/alternative fuel aircrafts and supporting infrastructure) → planning and design projects to come
 - Planning grant open for MPOs/RPOs/municipalities for advanced air mobility planning (Electric Vertical Take-off and Landing Aircraft [eVTOL])
 - Grant intended to be annual reoccurring
 - Potential future of transit (potentially public)
 - ~6–8-person capacity
 - o Connecting rural hubs to hospitals/medical care
 - Other states implementing/planning: Florida, California, Washington
 - Launching healthcare consortium this year

Ferry

- Unique work that can vary widely makes it difficult to find expert resources (facilities, marine assets, vessel construction, operations)
- Working to identify resources for vessel construction with upcoming RFLOI
 - Idea for firms to partner with maritime industry
 - Opportunities to expand maritime network:
 - Passenger Vessel Association, Interferry, Public Ferry Coalition, Transportation Research Board

- Division recently went through verified claims potential to pair a consultant with Ferry Division staff
- Future of service to Ocracoke Island with erosion of NC 12 serving residents, tourists, and meeting goals of National Park Service
- Invoice processing
 - IMD to push out invoice expectation guidance, new hires/innovative technology should help speed up processing time
- Contracts Updates

 - Rail Crossing Safety/Planning RFLOI's posted
